Meeting of the Aquinnah Select Board December 14, 2021

Minutes

(Deferred consideration of Minutes of 11-30-2021)

Building Inspector

(Appointed Forrest Filler as Temporary Building Inspector)

Town Administrator informed the Board of efforts to find a fill-in for Len Jason during his unexpected unavailability. Contacts were made with other towns and an interview was held with both Forrest Filler and Ken Barwick, a former inspector in Tisbury. Barwick said he was unable to consider the position at this time. Forrest Filler is available and capable of filling in starting immediately. He is qualified as holder of a Construction Supervisor's License but unable to issue certificates of occupancy as that requires more licensure than he currently has. Juli ultimately made a motion to appoint Forrest to the position. Her motion was seconded by Gary and the vote was unanimous.

M.V. Youth Taskforce (No action requested)

Theresa manning and Mike Joyce attended the meeting and gave a report on the Taskforce. The Task Force provides substance Abuse Services to troubled youth on the Vineyard and has received over \$2M in funding over the years. Previously the Task Force used the County as the fiscal agent for the finding but has changed that policy after qualifying as a non-profit and now uses Aquinnah as its lead agency to qualify for funding. Theresa informed the Board that the Task Force seems to have achieved success in changing attitudes of Vineyard teens from thinking that drinking is a "right of passage." As a result they have been able to address whatever abuse may be taking place at any given time; be it vaping, anxiety or drug abuse. She extended thanks to Aquinnah Board for its cooperation in their program.

Healthy Aging Survey Results (Accepted Report)

Cindy Trish from the Healthy Aging presented results of the Survey of Island-Wide Older Adults (60+) they conducted. Dan Doyle from the MVC participated in compiling data. Some of the data compiled in the report: The report anticpates an increase of 40% in Aquinnah older population by 2035. There were 70 respondents from Aquinnah who answered 68 questions. 1 in 4 older adults in Aquinnah live alone. 1 in 4 older adults in Aquinnah have provided care to a family member in the past 2 years. 13% of Aquinnah respondents have utilized the COA.
