Dear Karen,

In reply to the Aquinnah Building Committee's request for a fee proposal for extended schematic design services for the Town Center, ICON proposes working on an hourly basis with a Not-to-Exceed fee of \$4,000. We understand the committee's goal to be the conceptual development of three options for the modernization of the Town Center campus. All Owner-Architect meetings will be virtual. On-site meetings are \$2,500/meeting. For this fee, ICON will develop sketches of the revised designs and meet with the cost estimator.

In addition, the estimates can be approached in one of two ways:

- 1. An opinion of probable cost developed based on the Schematic Design estimate for each option at a *conceptual* level. This will allow an order-of-magnitude comparison.
 - a. The fee for this effort is \$3,000.

OR

- 2. Detailed cost estimates can be developed for each option along with a summary comparison. This will provide greater certainty than the first approach and the ability to understand line-item comparisons.
 - a. The fee for this effort is \$8,000.

First Approach

Below are three sketches of the schemes we will be developing for further discussion.

Option 1: Three separate buildings – as previously presented to the ABC.

Option 2: Two buildings joining the existing Town Office building and the Police Department.

Option 3: Renovating the Town Office Building and renovating and adding on to the Police Department.

We understand that the goal of these studies is to identify significant cost reductions and the pros and cons of our suggestions. Additional detail can be found in the meeting minutes from January 5, 2023.

The Architect shall be compensated pursuant to an "Hourly/Not to Exceed" amount agreed to by the Architect and the Owner. The fees for the cost estimator are a lump sum. From the Notice to Proceed, the fee will be invoiced monthly on an hourly basis. Meetings and/or site visits beyond those identified in this proposal will be an Additional Service based on the hourly rates attached hereto Expenses (printing, parking & travel) are reimbursable at a rate of 1.10 times the actual cost.
